1.0 Background

The Site C Clean Energy Project (the project) is a hydroelectric dam and generating station under construction in northeast B.C. Construction started in July 2015 and the project will be in service in 2024. The project will help meet future electricity needs by providing 1,100 megawatts of dependable capacity, and producing about 5,100 gigawatt hours of energy each year — enough to power the equivalent of 450,000 homes per year. Once built, the project will be a source of clean, reliable and cost-effective electricity in B.C. for more than 100 years.

The key components of the project are:

- Access roads and a temporary construction bridge across the river, at the dam site.
- Worker accommodation at the dam site.
- Upgrades to 240, 269, 271 and Old Fort roads.
- The realignment of seven segments of Highway 29.
- Two temporary cofferdams across the river to allow for construction of the earthfill dam.
- Two new 500 kilovolt transmission lines connecting Site C to the Peace Canyon Substation, within an existing right-of-way.
- Shoreline protection at Hudson's Hope, including upgrades to DA Thomas Road.
- An 800-metre roller-compacted-concrete buttress to enhance seismic protection.
- An earthfill dam, approximately 1,050 metres long and 60 metres high above the riverbed.
- A generating station with six 183 MW generating units.
- An 83-kilometre-long reservoir that will be, on average, two-to-three times the width of the current river.

2.0 Environmental Assessment Certificate Requirements

The <u>Site C Construction Communications Plan</u> (the Plan) has been developed in accordance with the Conditions 39, 43 and 72 of the Environmental Assessment Certificate (EAC), and guides construction communications and community relations during the construction phase.

This annual report provides a review of the construction communications activities undertaken as part of the Plan during the third year of construction. Note that the reporting period covered by this annual report is **July 1**, **2018 – June 30**, **2019**.

Table 1 describes how BC Hydro is meeting the EAC Conditions that relate to the Plan.










Top Enquiry Topics

Appendix D. Letters, emails and mailings

Restorative Justice: Reclaiming the dignity of the human spirit

¬ ort St. John invests in Restorative Justice. The North Peace Justice Society offers firsttime offenders programs that center on youth mentorship and positive role modeling, exploring the negative effects of one's choices, and how to make more informed choices in the future to redirect youth that have become lost in terms of their choices.

Restorative Justice seeks to make things right. Conversely, Retributive Justice seeks only punishment and vengeance as justice. Restorative Justice seeks to understand what social breakdown formed the character of the accused and, where there is injury, emphasizes collective responsibility, forgiveness, and reconciliation between all parties.

St. Thomas Aquinas wrote of Restorative Justice in the

thirteenth century. Aquinas viewed retribution as an immoral act beneath the dignity of the person seeking vengeance and the individual awaiting punishment. Aquinas favoured Prospective Justice, the forbearer of Restorative Justice, which aimed at promoting the future good as it restored the human spirit presently torn down.

In the book of Genesis, after the fall of Adam and Eve, evil spread throughout the lives of God's people. Abel murdered Cain, his own brother. Lamech paid back any wrong done unto him seventy-seven times. An

out-of-control narcissist, his vengeance knew no boundaries. Lex talionis, or the 'law of giving back' from the book of Exodus (21: 23-25) states 'an eye for an eye, and a tooth for a tooth'; however, this law was actually a humanitarian principle. It limited vengeance by letting the punishment fit the crime and no more.

Christ views vengeance as heartless and pitiless. He tells His followers to be generous of spirit and in nature. When another does wrong, be princely and kind in return, says Christ. When they make demands that they have no right to make, offer them even more in return. People of faith are called

to view all through a lens of compassion. They must contribute to the rehabilitation of offenders, facilitating their transition from despair to hope and from unreliability

to dependability. The only way through disputes is to foster humane resolutions to crime and conflict. Christians are called to live by heart and head, and to pardon others as their own transgressions are pardoned.

In the parable of the Prodigal Son, much has been written with regards to the prodigal's wickedness. The very word 'prodigal' means extravagant and reckless. Yet, the elder brother's sins are far greater than that of the younger brother whose sin is his misspent youth. It is he who suffers most from his own thoughtless behavior. The older brother, envious of the younger, refuses to rejoice in his brother's awakening and homecoming. He tells his father, "All these years I've been slaving for you and never disobeyed your orders. Yet you never gave me even a young goat so I could celebrate with

my friends. But when this son of yours who has squandered your property with prostitutes comes home, you kill the fattened calf for him!" (Luke 15:29-30). He denies his blood, referring to his brother only as 'his father's son'. He wants his father to banish his younger brother, but this his father will not do. Rather, his father embraces his second son just as God, the Father runs to greet us with open arms each time we seek to return to the mantle of His love. God offers Restorative Justice

when we seek His mercy. We are called to offer the same to those seeking renewal and forgiveness.

Application to Amend Environmental Assessment Certificate, #E14-02, for the Site C Clean Energy Project

Invitation to Comment

BC Hydro, (the "Certificate Holder") has submitted an application for an amendment of the Environmental Assessment Certificate (EAC) #E14-02 for the Site C Clean Energy project (the "Project"), issued on October 14, 2014, and amended on June 22, 2018 under the *Environmental Assessment Act*.

The Project is located approximately 5 km southwest of Fort St. John, BC. The Project is made up of an earthfill dam along with the associated generating station, spillways, reservoir, substation, transmission lines, and Highway 29 realignments.

The application for amendment is focused on changes to the source of quarry and excavated materials used in some aspects of construction. The following change is proposed:

- · Revisions to allow for West Pine Quarry as a potential additional source of quarry and excavated material for the construction of:
 - · Highway 29 Realignment
 - · Hudson's Hope shoreline protection
 - Other areas along the reservoir requiring protection during reservoir filling

The public comment period is 30-days. During this period, the public is invited to submit concerns regarding *new* or *additional* adverse impacts that might result from the proposed amendment.

The intention of seeking public comments is to ensure that all potential effects – environmental, economic, social, heritage and health – that might result from the proposed changes are identified for consideration as part of the amendment process.

The comment period will begin on July 30, 2018, and conclude on August 29, 2018. All comments within the scope of the application for amendment will be considered as part of EAO's review.



Invitation to Comment

BC Hydro. (the "Certificate Holder") has submitted an application for an amendment of the Environmental Assessment Certificate (EAC) #E14-02 for the Site C Clean Energy project (the "Project"), issued on October 14, 2014, and amended on June 22, 2018 under the Environmental Assessment Act.

The Project is located approximately 5 km southwest of Fort St. John, BC. The Project is made up of an earthfill dam along with the associated generating station, spillways, reservoir, substation, transmission lines, and Highway 29 realignments.

The application for amendment is focused on changes to the source of quarry and excavated materials used in some aspects of construction. The following change is proposed:

- Revisions to allow for West Pine Quarry as a potential additional source of quarry and excavated material for the construction of:
 - a. Highway 29 Realignment b. Hudson's Hope shoreline protection
 - c. Other areas along the reservoir requiring protection during reservoir filling

The public comment period is 30-days. During this period, the public is invited to submit concerns regarding new or additional adverse impacts that might result from the proposed amendment

Construction set to begin on new water stations

Construction is set to begin on five new potable water stations throughout Electoral Area

The water treatment and bulk loading stations are being built in Buick, Rose Prairie, Feye Spring, Prespatou, and Goodlow starting this month, and work will carry on through to mid-October.

Water will be shut off at the stations for a period of no more than five days, the Peace River Regional District said in a news release Monday.

Advance notice will be provided so residents can make alternative arrangements for water, the district says. Only one at a time during construction.

The construction schedule is as follows:

- Buick, Rose Prairie and Feye Spring: mid-July to mid-September
- Prespatou and Goodmid-September mid-October

Construction is being carried out by Bear Mountain Construction of Dawson Creek, which was awarded a \$3.4-million contract in May. Flowpoint was awarded a \$1.5-million contract to supply the water treatment equipment and pre-fabricated buildings last December.

In a referendum held last June, Area B residents voted overwhelming in favour of establishing a potable water function.

The need to convert existing untreated water facilities in the region arose when provincial regulations began requiring all regional districts to provide station is expected to be down treated water or no water at all. The district would be liable if contaminated water from a PRRD well causes illness or death.

> In November 2015, a similar proposal for potable water services through new property taxes in Areas B, C, and D was defeated by voters.

Fort St. John Votes: Meet Lilia Hansen

vying for six seats on Fort St. John city council, and an incumbent councillor seeking re-election after winning a byelection in 2017.

Hansen is executive director for the Fort St. John Chamber of Commerce and is seeking a second term after winning a byelection in 2017. Hansen wants to see the city encourage more in-fill development rather than sprawling out, give more tools to the city's economic development team, and keep the public involved in the feedback and consultation loop.

Name: Lilia Hansen **Age:** 48

Neighbourhood: Northeast quadrant **Occupation:** Executive Director of the Fort St. John & District Chamber of Commerce

1. Why did you decide to run for council?

I want to make a positive impact on my community, today and for the future, and bring the voice of my neighbours to the table. I have the ability to bring concerns and possible solutions to the attention of decision makers by being present at meetings when the average citizen cannot attend personally due to work or other commitments. I meet with business and non-profit organizations regularly. They need someone to help get their message across as to their ideas, wants, and needs.

2. What experience and skills would you bring to council?

Building relationships is one of strengths I've developed as the Chamber's executive director for almost five years, and being a board member for Community Futures - Peace Liard. Seeking input from those in the know (aka the boots on the ground) to compliment the work of city staff is important to cover as many possible issues that may arise. Sometimes the best solution can be the simplest. You need to reach out and get input.

3. What would be your top three priorities if elected, and why?

My top three priorities are economic development, responsible fiscal spending, and quality of life of citizens – accessible and multi-generational. The reasons these are my priorities: You need jobs to keep people in our community and give them opportunities for advancement. here which means budgets and spending has to be reasonable and balanced families in the north. with average earnings. Quality of life will attract and retain people to Fort St. John. We want families to grow and stay here and we need the services for them to be able to do so.

4. What programs or services should the city spend more on?

Roads, water, and sewer are primary services that should be maintained and new infrastructure installed. We pay a fair dollar in taxes and expect these services to be in good repair. It's not the topic that gets a lot of media attention but they sure are noticed when not in working order.

5. What programs or services should the city spend less on? We all want the city to tighten its belt, spend the minimum amount, or even less then is currently being done. The question should be what are the citizens of Fort St. John willing to do without if they want budgets to come down? It's my understanding that the city cut their budget by encouraging each department to find savings - approximately 10% this year. The city prioritizes its services based on community consultation and feedback. I believe the community should be consulted on all changes to services as the city works for its residents, not the other way around.

6. Would you support raising taxes to support council priorities?

There would have to be a significant gain to the majority of the community to have my support of raising taxes. Priorities of the community should be reflected, not those solely of council.

7. What should the city do to attract new industry and business?

Giving the tools and support to the city's economic development department to work with industry and businesses looking to locate in Fort St. John is important.

Lilia Hansen is one of 12 candidates Business needs to know the city supports both our current businesses and welcomes new ones. It's important to support our current businesses, not just focusing on attracting new ones. Our current businesses should be shown just as much, or more, co-operation and help to grow their business and stay in business. They've proven they have skin in the game and have invested in our community. If we want to attract new industry and business, we need to gain the reputation for working well with them.

8. What should the city do to stimulate downtown investment?

Work with investors and landlords to fill our vacant commercial spaces, encouragement on in-filling versus building out. The city's official community plan hopes to attract both residents and businesses to the downtown core by blending the use.

9. What has been the city's greatest achievement over the last four years?

Leading the way in ingenuity by building a northern passive house and proving it works in our northern climate, and the micro-hydro power project that pipes treated water from the city's south lagoon wastewater facility to a turbine to generate electricity. The latter project builds on the city's commitment to sustainability, energy efficiency, and conservation.

10. What has been the city's greatest failure over the last four years?

Not getting the message out to more people as to the core reasons for why decisions were made. The city needs to explain the pros and cons of basing their decisions with a lens 20+ years down the road. A decision made without looking forward could be a lost opportunity. The city purchasing land to hold for future school sites is a good example of planning for the future.

11. What's the biggest opportunity facing the city over the next four years?

Working with partners and the provincial government to create more learning spaces and skilled training opportunities in our area, such as the registered nursing program. Our community is growing and we need more schools and services to keep our students in the north, and hopefully then they'll stay and work in the north. Application to Amend Environmental Assessment Certificate, #E14-02, for the Site C Clean Energy Project

Invitation to Comment

BC Hydro, (the "Certificate Holder") has submitted an application for an amendment of the Environmental Assessment Certificate (EAC) #E14-02 for the Site C Clean Energy project (the "Project"), issued on October 14, 2014, and amended on February 12, 2019 under the Environmental Assessment Act.

The Project is located approximately 5 km southwest of Fort St. John, BC. The Project is made up of an earthfill dam along with the associated generating station. spillways, reservoir, substation, transmission lines, and Highway 29 realignments.

The application for amendment is focused on changes to the design of Highway 29 realignment at Cache Creel/Bear Flat.

The following change is proposed:

Revisions to allow a change in the route of the Cache Creek segment of the Highway 29 realignment, including refinements to the route and lengthening the bridge. The new route is located north of the original allorment in the FAC

The public comment period is 30-days. During this period, the public is invited to submit concerns regarding new or additional adverse impacts that might result from the proposed amendment.
