Atlantic Mining Nova Scotia Inc (AMNS; the Proponent), a wholly owned subsidiary of St Barbara Limited, is following up on correspondence of March 3, 2022, as well as prior correspondence on April 27, 2021, on the above noted matter.

As Proponent of the Fifteen Mile Stream Gold Project (FMS Project, the Project), we request an extension to the Three-Year Time Limit to Submit Required Information and Studies under CEAA 2012. The requested time extension to complete all studies and information is three years (30 months for completion of EIS, IRs, all studies, and information plus a 6-month allowance for contingency / unforeseen activities). Key reasons for our request are as follows:

- The EA process is well advanced and has entered the IR stage;
- The principal Project elements / operations remain unchanged and are being optimized;
- EIS guidelines for the Project remain valid;
- Engagement with First Nations and local communities has reached the IR stage; and
- A restart under IAA 2019 is likely to cause significant delays and jeopardize Project realization.



AMNS is confident that we will complete our contributions to the EIS process within the requested additional 3-year timeline. In support of our request, we have assembled the information attached as suggested in your letter of April 27, 2021. We trust that the information provided meets IAAC's requirements to grant the three-year extension to allow us to complete the further consultations and provide the information for the EA of the Project.

Atlantic Mining Nova Scotia Inc - Fifteen Mile Stream Gold Project Application for an Extension to the Three-Year Time Limit

1. Introduction

This document has been developed in support of Atlantic Mining Nova Scotia Inc's (AMNS) application for a timeline extension pertaining to the Environmental Assessment (EA) process for the Fifteen Mile Stream Project (FMS Project, the Project). AMNS is requesting an extension to the Three-Year Time Limit to Submit Required Information and Studies under CEAA 2012.

The requested time extension to complete all studies and information is three years (30 months for completion of Environmental Impact Statement (EIS), Information Requests (IRs), all studies and information plus a 6-month allowance for contingency / unforeseen activities). Without the approval of the timeline extension, AMNS would be unable to successfully complete the EA process under CEAA 2012. Instead, the EA process would require a restart to be conducted in accordance with the *Impact Assessment Act* (IAA) of 2019.

This document outlines AMNS' reasons for the extension request, explains recent Project changes, outlines accomplishments to date and provides AMNS' workplan to complete remaining tasks within the requested timeline. The text concludes with a summary of why, from AMNS' perspective, the EA process should continue pursuant to CEAA 2012.

2. Reasons for time limit extension request

2.1. Additional data collection and effects assessment work

- AMNS requires additional time to complete complementary field data collection to address public concerns and interests as expressed in the received IRs.
- AMNS requires additional field time to complete comprehensive drilling work to
 identify and delineate historic tailings and contamination in soils and sediments at
 and near the Project site. This is needed to address the province's requirements for
 managing historic tailings under the provincial contaminated sites regulation. The
 work recently commenced and is being conducted in close consultation with Nova
 Scotia Environment and Climate Change (NSECC). This program was intended to
 begin during the winter of 2021/2022; however, capacity and availability of drilling
 contractors was limited causing some delay.
- Some aquatic, floristic and faunistic field data require additional surveys to ensure environmental conditions related to Project changes (e.g., power corridor, access routes; see also Item 2) are adequately documented. This requires work during 2022, outside of the winter months and involves:
 - Seasonal surveys for migratory birds, moose, fish and fish habitat
 - Seasonal noise monitoring
 - Seasonal wetland hydrology monitoring
 - Seasonal water quality and flow monitoring



- From the IRs received, a Dam Breach and Inundation Study is required for the proposed TMF. Due to capacity issues and availability of subject matter expertise, analysis is expected to start in Q1 2023 and will require approximately 6 months.
- A Traditional Land and Resources Use Study (TLRUS) is required to respond to the IRs. This is a lengthy process involving direct engagement with the Indigenous Community. There has been a delay initiating this program due in part to the limited number of qualified consultants with a record of successful engagement. The identification of a qualified consultant involved a prolonged search, and this has now been achieved. Work is due to start Summer 2022.
- Additional time is required to perform complementary model runs to solidify Project design decisions and to demonstrate effectiveness of environmental protection measures The work can only start upon completion of the field data collection and is driven by the IRs and Project optimization.
- Considerable time is needed to comprehensively respond to all IRs received to date.
 This includes the generation of clear and concise supporting documents.

2.2. Project changes

- The nature of the Project and operational aspects remain very similar to the current Project Description. Current Project changes reflect optimization efforts related to environmental protection, Project life, and economic and community benefits. The EIS guidelines for the Project therefore remain valid; however, minor Project changes necessitate some complementary baseline data collection and updating of effects assessment work (see Section 2.1).
- The key Project changes that AMNS is currently developing involve:
 - Potential TMF cover/liner design (re-evaluation in response to IRs);
 - Development of three additional pits within the existing site boundaries (and associated adjustments to internal layout of access roads, drainage, stockpiles, and work areas);
 - Revised re-alignment of Seloam Brook within the site boundaries including updates and details pertaining to on- and offsite offset measures;
 - Adjustments to site access/detour roads in response to IRs/ public feedback;

2.3. Stakeholder engagement activities

 Since inception of the Project AMNS has been continuously engaging with First Nations, local communities, and stakeholders and have fostered good working relationships with all affected parties (see Attachments A to C). The Project has triggered substantial interest among communities and stakeholders and has involved comprehensive communication on a wide variety of issues and concerns.



- Requirements towards AMNS' management of historic tailings within and near the Project boundaries are being discussed by AMNS and NSECC. Implications for the Project are potentially significant. Coming to a mutually beneficial arrangement is taking more time than anticipated.
- Mi'kmaq community engagement / involvement in a TLRUS is critical to address First Nation community concerns. AMNS is committed to working closely with First Nation communities and accommodate their needs, timeframes, and resources as much as possible. The schedule for completing the required work is therefore effectively out of AMNS' control. However, a re-start of the EA process under IAA has the potential to harm the ongoing engagement process and cause further delays.

2.4. COVID-19 related delays

- COVID-19 restrictions imposed limitations on the AMNS team, its consultants, First Nations, local communities, regulators, and stakeholder groups. It caused inefficiencies and slowed down progress. The impacts of the restrictions were manyfold and entailed:
 - Significant interruption to First Nation engagement activities caused by COVID-19 outbreaks resulting in cancelled meetings.
 - o Reduced regulator capacity and availability due to medical issues.
 - Transportation interruptions (interprovincial and international) during imposed travel restrictions resulted in reduced commercial flight availability impacting access by technical specialists to Project sites, First Nation consultation, and data collection.
 - Reduced capacity throughout this period and into 2022 continues to impact industry logistics by disrupting supply and value chains and delaying the flow of personnel and materials. AMNS addressed capacity by adding members to the Project consultant team to improve responsiveness and provide consistency.
 - Additional personnel and schedule were required for field and survey programs due to strict COVID19 safety protocols and restricted mobilization.

2.5. Other issues contributing to the delay

- In 2019, St Barbara completed the acquisition of Canadian gold producer, Atlantic Gold. Although St Barbara attempted to limit disruption to Atlantic Gold projects, the acquisition necessitated some pauses to review legacy operations and plan for alignment with St. Barbara standards and expectations. This initially resulted in some impacts to the FMS Project schedule as the new corporate management, technical resources, and objectives transitioned and communication and decision interfaces were established. St Barbara management structure is now in place with onsite corporate leadership locally in Nova Scotia to ensure expedited decision making for the remainder of the Project's execution.
- Reduced staff within AMNS (partly due to Covid-19 impacts and isolations) resulting
 in team members needing to be committed to multiple projects (up to April 2021);
 AMNS has recently increased staff size to provide capacity and expedite future
 Project development.



3. Project Accomplishments and Proposed Work Plan to Completion

3.1. Accomplishments to date

- Notice of Commencement on 17 July 2018.
- Completion of comprehensive baseline studies.
- Submission of EIS in Oct 2019.
- Submission of Revised EIS on 10 Feb 2021.
- Commencement of Round 1 IR responses.
- Initiation of supplementary field programs & complementary modelling, including:
 - Geotechnical borehole drilling
 - Source terms update
 - Additional historical tailings delineation
 - o Expanded flora, terrestrial fauna, and avifauna field surveys
 - o Groundwater & surface water modelling update
 - Seloam Brook Realignment design update
 - Expanded fish/fish habitat field surveys
 - Expanded wetland hydrology monitoring
 - Expanded Species of Conservation Interest and Species at Risk surveys
 - Extended water quality and flow monitoring
- AMNS is committed to the development of the FMS Project and has spent approximately \$47 million to date. This investment demonstrates AMNS is a serious proponent that will devote the necessary resources to complete the approval process and design work within the agreed timeline.
- It should also be noted that IAAC, NSECC, and other regulators have also contributed major effort to date in the current ongoing review. AMNS is respectful of this public service investment and will ensure that effort is captured within the extension timeframe.

3.2. Work Plan (Schedule to Completion)

- The requested time extension to complete all studies and information is three years.
 This entails 30 months for the completion of an updated EIS, responses to the current round of IRs, responses to additional rounds of IRs, and documentation of all associated and supporting studies.
- A work breakdown and associated timelines are shown in the simplified schedule below.
- Note that the work plan provides a 6-month allowance for contingency / unforeseen activities.

- The preparation of responses to the Round 1 IRs is well underway. This process takes
 significant time due to the number of questions that require re-evaluation of fundamental
 design decisions. Long-term follow-up studies with seasonal components and/or
 prolonged stakeholder engagement are needed. AMNS is ensuring adequate supporting
 information is collected during development of these responses so that the subsequent
 IR rounds do not require additional seasonal fieldwork and supplementary studies.
- AMNS also plans to engage with Stakeholders and regulators prior to the submission of the Round 1 IRs to reduce the number of IRs received in subsequent rounds.
- It is anticipated that future IR rounds will have fewer comments and that the nature of these will be related more to the clarification of details and that the core design and nature of the project will have been adequately addressed during Round 1.
- AMNS has implemented measures to increase capacity of the Project management team with new dedicated positions and additional support staff. This will ensure that the future EA process will be executed by AMNS in a timely manner.

4. Conclusion / Summary – Rationale for EA process to continue pursuant to CEAA 2012

AMNS appreciates the opportunity to provide details regarding this request for an extension to the legislated time limit for the Fifteen Mile Stream Project. The EA process for the FMS Project is well advanced and has entered the IR stage with most of the baseline data assembled and designs now completed. AMNS' current effort focuses on supplementing the information base and updating studies largely driven by the Round 1 Information Requests and on-going Project optimization. These requirements are well understood, AMNS' efforts are clearly defined, and a concise workplan is being followed (See Section 3.2, above).

Engagement with First Nations and local communities has been on-going and comprehensive with positive feedback received to date. This engagement has generated interest in the Project and receipt of several Information Requests. AMNS believes that a re-start of the EA process under IAA 2019 would negatively impact these working relationships by causing confusion among stakeholders, fostering engagement fatigue, and potentially introducing resentment toward the Project.

A re-start would require additional time and is likely to adversely impact investor interests and AMNS' ability to finance the EA work. AMNS is committed to providing the information within the extension period granted by IAAC before the time limit has expired, and in doing so, wishes to avoid significant impacts such as consultation fatigue, unnecessary use of federal government resources, and duplication of effort by all involved.
