Dear Webequie Supply Road Team,

Noront appreciates the opportunity to comment on the Webequie Supply Road (WSR) Draft Terms of Reference (ToR), in response to your notification of September 16, 2019. We reviewed and commented on the WSR Project Description for CEAA last month and appreciate that some of our information was applied for the new document.

Noront is the major mineral claims holder and only company with advanced resource projects in the Ring of Fire (RoF) region, to which the WSR will connect. Noront has placed on hold a permitting process for the Eagle's Nest Mine Project, which had included road access from Pickle Lake. Noront has publicly stated that it no longer includes an access road in its project description, since the Province of Ontario on August 21, 2017<sup>1</sup> announced support for First Nation proponents to develop roads to the Ring of Fire from Nakina and Pickle Lake. When Noront restarts its permitting process, the project scope will include a mine accessed via an all-weather road from Nakina (built by others) connected to the provincial highway system, with air service via the Muketei Airstrip located 3km north of the proposed mine site. Since Noront is no longer the proponent for the road from Pickle Lake, there are no conflicting interests with Webequie's proposed access road.

Without an all-season road connected to the provincial highway system, Noront does not believe any of the known deposits in the Ring of Fire are economic and will not be developed into mines, since shipping more than 150,000 tonnes per year of concentrates (first mine) and receiving consumables like fuel, reagents and cement can only be done safely and economically by a road.

Noront will use the Muketei Airstrip for moving people to and from the site for reasons of cost and safety, since 107km of gravel road to an airstrip would not be suitable for airlifting people for an evacuation or medical emergency.

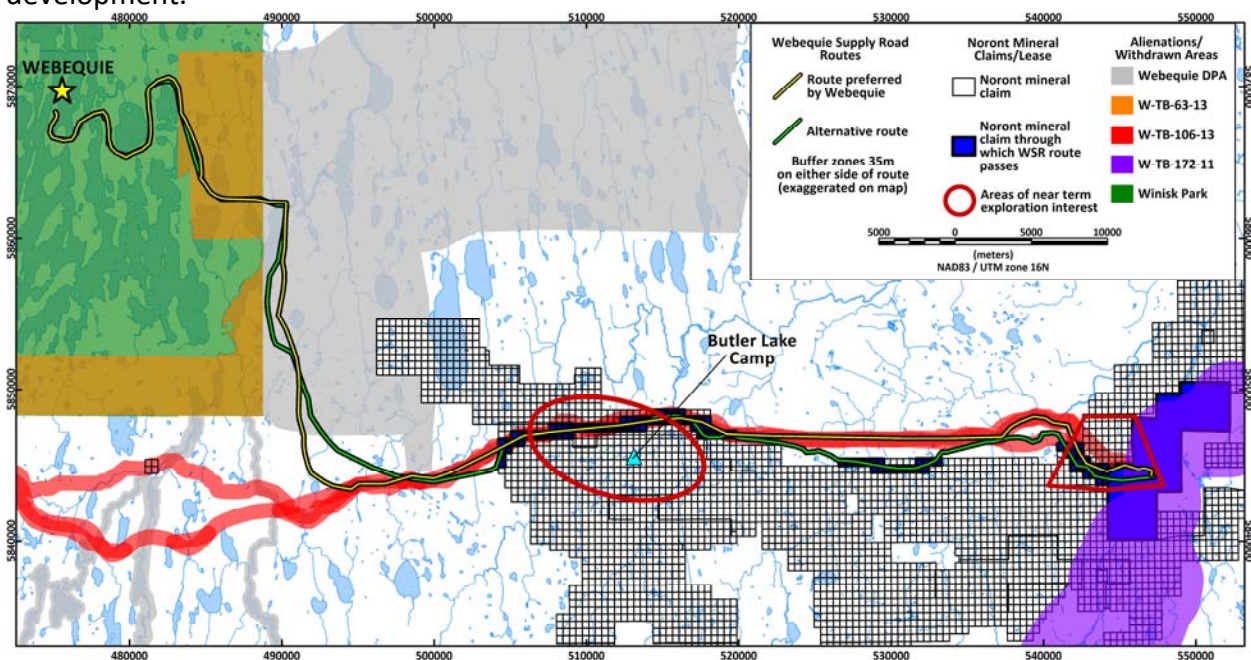

Noront is strongly in favour of a road between Webeque First Nation and the Ring of Fire region since this will allow Webeque community members to participate in the developments. Noront sees Webeque supplying services and personnel to the future mines. Noront already employs community members for our exploration work. The road will also provide community members with access to the provincial highway system.

Noront has supported the WSR design team by supplying information from Noront’s studies of road alternatives in this area. This work included assessing aggregate sources and descriptions of wetland road building techniques. Noront welcomes further opportunities to share information with the WSR team.

The WSR road corridor, alternative route and associated buffer zones (35m width on either side of the routes) cross 109 mineral claims held by Noront, as well as part of Noront’s Eagle’s Nest Mining Lease, as illustrated in the figure below. Of the mineral claims, 56 require formal consent, by Noront, for the disposal of surface rights, as they were staked prior to the surface rights being withdrawn starting in 2011. Furthermore, Noront has near-term exploration interests in certain portions of these claim blocks. Thus, Noront requires detailed discussion with Webeque on road placement as the project advances, so key mineral opportunities are not impaired by the road development.



Also noted in the figure are Withdrawal Order W-TB-63-13 (a withdrawn area between Webequie First Nation and the Winisk Park withdrawn area, and Webequie's proposed Designated Protection Areas under their draft Community Based Land Use Plan), as well as Withdrawal Order W-TB-172-11 (the North-South corridor) should be discussed further.

The Ring of Fire region could be active for over 100 years, given the large amount of chromite and other minerals. This supports the justification for the WSR.

In closing, Noront appreciates the efforts Webequie First Nation has made towards developing a supply and community access road. Noront is very open to further communications and discussions as the road studies advance.

I, Aex Cande, phoned you November 14<sup>th</sup>. You were in Toronto at the time, and suggested I call you back about the end of November at which time you expected to have more certainty as to the Road to the Ring of Fire. It is now past that time.

I believe I have the ability and can assemble the resources to build that road, and have confidence in my concept and approach which uses a floating roadbed on an 80 foot base using a corduroy pad and shredded tires as a base to support the upper crowned road.

A road such as that has not been built in Canada, but I believe I can accomplish that to the Ring of Fire. I am working with partners and expect to form a joint venture capable of doing the job. As you are aware the MTO and MOECC have built a test road using this concept. Initial documentation was forwarded by Betty Bennett, who has now retired. She is replaced by Susan Chan who is now with the MTO as Senior Pavement Design Engineer, and who continues to support the concept.

I have also arranged conditional start-up financing with the objective of setting up operations on site and constructing local access roads using that concept. Such financing, to the extent of \$12 million, is available until the end of December, on commitment. Delays would result in losing a year in getting the concept up and running. I estimate there is a 2 year lead time prior to field construction.

For a North-South road from Nakina, bridge crossings will be expensive. An East-West road from Pickle Lake is expected to be cheaper and faster.

I believe I can also assist in convincing levels of government to contribute to the venture, as well as sourcing other financing. I would like to restrict access to my proposal in the early stages, at least up to the point of commitment. We should meet to discuss the concept and the conditional financing as soon as you can arrange a suitable meeting in Toronto. As well, advance notice is always preferable so that we have time to respond adequately to any questions.

I would appreciate the courtesy of a reply as I have sent out other requests for an expression of interest. May we hear from you before the end of the month?

I await your reply. Please direct it to Fran Yungwirth's attention.



Noront cannot rely on an airstrip located over 100 km away for developing or operating its facilities in the Ring of Fire. The WFN airstrip will also support activity in the region.	Noted.

Noront believes these and undiscovered mineral deposits along the WSR should be added to the rationale for the undertaking. The EA documentation will describe anticipated activities during the operation phase of the Project, including anticipated road use by different users (traffic volume, type of vehicles, maximum weight, etc.). This could include any anticipated use by Indigenous groups, the general public, and proponents of reasonably foreseeable future projects (e.g., Eagle's Nest, Blackbird, Black Thor, Black Label, Big Daddy, etc.).
NR-5	4.3.2, Last Paragraph, Road Controls	Noront and other industry companies may want to use the road where it provides access to exploration targets and mineral deposits. Road control elements should consider such shared use and future connection to the Provincial Highway System and associated requirements for vehicle permitting and insurance.	Noted. The operator of the Webequie Supply Road, including consideration of road uses and/or access controls, is not known at this time and is part of future discussions and agreement on the ownership of the facility with the Province of Ontario. Further details on potential road control elements for the WSR will be described in the EA documentation.

As cited in the ToR Table 5-2, which details the Webequie community based considerations for the initial screening of supply road corridor concepts, boreal caribou populations require large undisturbed areas of old and mature conifer upland forest and lowlands dominated by jack pine and/or black spruce. They are also found in bogs and fens. The fact that both of these habitat types exist in proximity to the alternative road corridors, as do known caribou calving and nursery areas, it's recognized this sensitive habitat will be carried forward into the EA phase for the evaluation of alternatives. In addition, we note the inclusion of the following indicators for Caribou Habitat Protection in the ToR Appendix B (List of Preliminary Evaluation Criteria and Indicators): "Category 1: High Use Area – Nursery Areas Habitat potentially impacted" and its attendant sub-indicators, including Number of Nursery Areas within the Range; Number of Nursery Areas potentially impacted by the Project (e.g., how many intersect with project footprint, are within 2 km, are within 10 km); relevant information on that habitat, such as average age of forest, condition of forest, etc. for each Nursery Area potentially impacted by the Project; Area (ha) of each Nursery Area potentially being impacted; and Area (ha) of each Nursery Area removed by Project.
NR-7	5.1.1.3, Hoverbarge	Another disadvantage is the large consumption of diesel fuel to lift and propel, especially for heavy-lift hovercraft.	Noted.
NR-8	5.4.1.1, Routing Considerations	Noront would like areas of prospective mineral importance to be considered as well. One of the most important considerations was that the East-West corridor would provide potential for more First Nations to potentially benefit from a connection to the provincial highway system."	We are unclear as to the nature of the assertion of an incorrect statement. The paragraph cited is considered a valid statement in addition to those comments noted by Noront.
