**Subject: Response to Questions regarding development in the Ring of Fire Area**

The Impact Assessment Agency of Canada has received an email from David Peerla on behalf of Neskantaga First Nation dated August 28, 2020. The email requested information from the Agency related to recent announcements and other developments in the Ring of Fire area. The objective of this letter is to respond to your questions to the greatest extent possible. Responses to questions raised by David Peerla and Wayne Moonias on October 6, 2020, during a telephone call, will follow in a separate letter.

**Concerns Related to the COVID-19 Pandemic**

The Agency acknowledges Neskantaga First Nation's concern regarding the COVID-19 pandemic and its effects on the consultation processes and the ability of Neskantaga First Nation to participate meaningfully in the impact assessment process. The Agency provided details in our June 15, 2020 correspondence, outlining how the Agency has adjusted its conduct for COVID-19.

The Agency is committed to substantive, meaningful, and respectful consultation throughout the impact assessment process and will work together with Indigenous groups to identify opportunities to support participation in the context of the ongoing pandemic.

**Provincial Coordination**

At this time, the Agency does not anticipate changes to the coordination of the federal impact assessment and provincial environmental assessment activities in light of comment periods for the provincial Terms of Reference for both the Webequie Supply Road or Marten Falls Community Access Road projects.

The Agency will continue to coordinate consultation on the projects with provincial officials to the extent possible, as outlined in the Cooperation Plans<sup>1</sup>. If this approach should change, the Agency will notify the Indigenous groups identified in the Indigenous Engagement and Partnership Plans<sup>2</sup>.

### **Eagle's Nest Project**

On August 9, 2019, the Agency notified Neskantaga First Nation that the federal environmental assessment process for the Eagle's Nest Project would be terminated. On August 28, 2019, the *Impact Assessment Act* (IAA) came into force, replacing the *Canadian Environmental Assessment Act, 2012*. As a result, the comprehensive study for the Eagle's Nest Project, which was being conducted under the former *Canadian Environmental Assessment Act*, was terminated per the transitional provisions of the *Impact Assessment Act*. The Eagle's Nest Project, as proposed by Noront Resources Ltd, is not a designated physical activity as described in the *Physical Activities Regulations* (the Regulations) of IAA. Additionally, the termination of the federal environmental assessment process does not preclude any other federal legislative, regulatory and constitutional requirements that may be applicable to the Eagle's Nest Project.

The Agency's Ontario Region Office has no information regarding statements from Noront Resources Ltd. about the meeting with the Minister of Natural Resources, the Honorable Seamus O'Regan.

### **Regional Assessment in the Ring of Fire Area**

### **Status of the Northern Road Link**

As per our correspondence to Neskantaga First Nation on June 15, 2020, the Agency has not been provided with an Initial Project Description by Marten Falls First Nation and Webeque First Nation. Upon the submission of an Initial Project Description that complies with the *Information and Management of Time Limits Regulations*, the Agency will notify Indigenous groups who may be impacted by the Northern Road Link of a formal comment period to seek their views on the Initial Project Description and whether an impact assessment should be required for the Northern Road Link.

As you share information with the Agency regarding the Regional Assessment and/or the impact assessments for the road projects, please feel free to identify any information or knowledge that can be considered across multiple assessment processes.

Information for the road project assessments or the Regional Assessment may be posted online via the Registry Internet site, subject to certain exceptions related to privacy, security or confidentiality.
