On February 10, 2020, the Minister of Environment and Climate Change determined that a regional assessment will be conducted in an area centred on the Ring of Fire mineral deposits in northern Ontario, approximately 540 kilometres northeast of Thunder Bay and 1,000 kilometres north of Toronto. The Minister directed the Impact Assessment Agency of Canada (the Agency) to engage with Indigenous groups, non-government organizations, the Province of Ontario and other federal departments to discuss appropriate activities, outcomes and spatial and temporal boundaries for the regional assessment.

In consideration of the preamble, purposes and provisions of the *Impact Assessment Act*, (the Act) the Agency has proposed that the goal of the regional assessment be as follows:

To provide information and analysis regarding future developments in the Ring of Fire area and their potential effects to inform and improve impact assessments and other planning and decision-making processes in a way that helps protect the environmental, health, social and economic conditions of the area while also creating opportunities for sustainable economic development.

In accordance with Section 100 of the Act, the Agency requests input from <<Department>> to inform the design of the regional assessment process and the development of the terms of reference for the assessment. The above-stated proposed goal of the regional assessment should be considered by participating departments when formulating their information and advice on this matter.

Please ensure that your designated official responds to the items detailed in the attachment to this letter by January 15, 2021. Any information requirements not specified in the attachment may also be provided. Your response will be posted on the Canadian Impact Assessment Registry Internet site (the Registry). Note that, all records produced, collected or received that are relevant to the regional assessment will be posted on the Registry unless they are excluded for privacy or security reasons, or are determined to be otherwise protected or excluded.
