On May 5, 2021, the Impact Assessment Agency of Canada (the Agency) accepted the Initial Project Description for the Phase I Vista Test Underground Mine and Vista Mine Phase II Expansion Projects (the Projects) from Coalspur Mines (Operations) Ltd. as meeting the requirements of the *Information and Management of Time Limits Regulations* under the *Impact Assessment Act* (the Act). As of today, the 180-day planning phase of the impact assessment has commenced. The Agency has announced the start of a 20-day comment period (http://iaac-aeic.gc.ca/050/evaluations/document/138949?culture=en-CA), inviting the public, Indigenous groups and other jurisdictions to provide feedback related to the Projects and inform the Summary of Issues. Once completed, the Agency will provide the Summary of Issues to the proponent.





In accordance with subsection 13(1) of the Act, the Agency requests your department's or agency's¹ input to identify its responsibilities and expertise related to the Projects and to inform the Agency's preparation of the Summary of Issues. Attached to this letter is the Federal Authority Advice Record form that the Agency requires your department to complete and return by no later than **May 26, 2021**. Your department is encouraged to provide as much detail as practicable in describing the potential issues that may be of relevance or concern in relation to the Projects. You are also required to provide a concise synopsis of each issue for inclusion in the Summary of Issues.

Concurrent with the initial comment period, the Agency will convene a Federal Review Team comprised of representatives from the relevant federal authorities. The Agency will develop, in consultation with federal authorities, a projects-specific work plan that sets out the detailed tasks, deliverables and timelines, consistent with the Act's legislated time limits, for each phase of the impact assessment. The work plan may be updated as the assessment of the Projects progresses.

For your future reference, after the proponent receives the Summary of Issues, it is required to submit a Detailed Project Description that includes an explanation of how it intends to address the issues raised. The Agency may contact your department for information or advice at that time for the purpose of determining if the Detailed Project Description is complete. Following acceptance of the Detailed Project Description, the Agency may seek the opinion of your department to inform the Agency's decision on whether an impact assessment of the Projects is required.

Please note that all records produced, collected or received in relation to the impact assessment of the Projects – unless prohibited under the *Access to Information Act* – will be considered public and posted on the Canadian Impact Assessment Registry website (Reference #80731).
