On September 21, 2020, the Impact Assessment Agency of Canada (the Agency) accepted the Initial Project Description for the Great Sandhills Railway Switching Operation at North West Terminal Project (the Project) from Great Sandhills Railway Ltd. Following the provision of the Summary of Issues to the proponent, the proponent will submit a Detailed Project Description in accordance with Schedule 2 of the *Information and Management of Time Limits Regulations*, including how it intends to address the Summary of Issues as per subsection 15(1) of the Act. This notice could be in the form of an annex to the Detailed Project Description wherein the proponent would provide a response to the Summary of Issues provided by the Agency. Following acceptance of the Detailed Project Description, if an impact assessment is required for the Project, the Agency will draft the Tailored Impact Statement Guidelines, and the various plans including the Cooperation Plan for review and comment.

The Agency would engage with the Ministry of Environment on the development of the Cooperation Plan. The Tailored Impact Statement Guidelines and plans, which includes the Permitting Plan, the Public Participation Plan, an Indigenous Engagement and Partnership Plan, and the Cooperation Plan, would be finalized

and issued to the proponent on or before day 180 of the planning phase, concluding the planning phase of the Act.
