Subject: Designation Request for the Proposed Erin Wastewater Treatment Plant Project under the Impact Assessment Act

On February 25, 2021, the Minister of Environment and Climate Change received a request to designate the proposed Erin Wastewater Treatment Plant Project (the Project) under subsection 9(1) of the *Impact Assessment Act* (the IAA). The designation request from the Coalition for the West Credit River is enclosed (Enclosure 1).

The Proposed Project

The Town of Erin is proposing to construct, operate and maintain a new wastewater treatment plant located southeast of the Village of Erin in Wellington County, Ontario. The Project would provide wastewater servicing to the Village of Erin and Hillsburgh. Treated effluent would be discharged to the West Credit River at Winston Churchill Boulevard.

The Project as proposed is not a designated project as described in the *Physical Activities Regulations*. The impact assessment process under the IAA only applies to designated projects.

Provincial Process

The Town of Erin has completed a Municipal Class Environmental Assessment for the Project to meet the requirements of Ontario's *Environmental Assessment Act.* In June 2018, the Government of Ontario received three Part II Order requests asking that the Town of Erin be required to prepare an individual environmental assessment. On August 29, 2019, the Government of Ontario decided that an individual environmental assessment is not required and allowed the Town of Erin to proceed with the Project, subject to any other permits or approvals required. The Final Environmental Study Report and the Government of Ontario's approval with reasons are available on the Town of Erin's project website at *www.wastewater.erin.ca/study_documents.*

Designation Request

Under subsection 9(1) of the IAA the Minister may, by order, designate a physical activity that is not prescribed in the *Physical Activities Regulations*. The Minister may do this, if, in the Minister's opinion, the physical activity may cause adverse effects within federal jurisdiction or adverse direct or incidental effects (resulting from federal decisions, including funding), or public concerns related to those effects warrant the designation. In accordance with subsection 9(4) of the IAA, it is expected that the Minister will respond, with reasons, to the request by May 26, 2021.

The Impact Assessment Agency of Canada (the Agency) will review information about the Project, any concerns expressed by the public and Indigenous groups, expert advice from federal authorities and input from provincial ministries and municipalities to prepare a recommendation to the Minister on whether to designate the Project. If the Project were designated by the Minister, the Town of Erin would be prohibited from carrying out the Project and would be required to submit an Initial Project Description, thereby commencing the planning phase of the IAA. During the planning phase, the Agency would determine whether an impact assessment is required.

Request 1: Please submit a lead contact for the Project to the Agency by **Wednesday, March 10, 2021**.

Request 2: Please complete and return the attached Federal Authority Advice Record by **Monday, March 22, 2021.** To facilitate your review of the information beyond the original letter from the requestor (Enclosure 1) and information from the Town of Erin that is publicly available, the Agency has asked the Town of Erin to provide any recent, relevant documents regarding the Project. The Agency will provide you these documents as soon as they are available.
