## Collaborative Assessment of Impacts on Rights Part 1: Approximate Locations of Exercise of Rights

The Impact Assessment Agency of Canada developed a series of worksheets designed to support a collaborative assessment of the Project's potential impacts on your community's exercise of Aboriginal and/or treaty rights. This document is the second of five worksheets and is an evolving document that would be updated based on information provided by your community throughout the impact assessment process. If you do not agree with the approach taken in this document, or if you wish to propose an alternative methodology to supplement our collaborative assessment of impacts on rights process, the Agency will consider and incorporate your preferences to the greatest extent.

<sup>&</sup>lt;sup>1</sup> All references to rights in this document refer to Aboriginal or treaty rights as described in Section 35 of the *Constitution Act, 1982 which states:* (1) The existing aboriginal and treaty rights of the aboriginal peoples of Canada are hereby recognized and affirmed. (2) In this Act, "aboriginal peoples of Canada" includes the Indian, Inuit and Métis peoples of Canada. (3) For greater certainty, in subsection (1) "treaty rights" includes rights that now exist by way of land claims agreements or may be so acquired. (4) Notwithstanding any other provision of this Act, the aboriginal and treaty rights referred to in subsection (1) are guaranteed equally to male and female persons.
