

Dear Chief Dylan Whiteduck:

On October 17, 2022, the Impact Assessment Agency of Canada (the Agency) suspended the 180-day time limit for the Planning Phase under the Impact Assessment Act for Crawford Nickel Project, upon request from Canada Nickel Company (the Proponent). Please see the public notice on the Canadian Impact Assessment Registry.

Once the Detailed Project Description and response to the Summary of Issues have been accepted, the Agency will post them on the Project's Registry web page, along with a notice that the 180-day time limit has resumed as of the date the documents were submitted.

The Detailed Project Description and response to the Summary of Issues will be used to inform the Agency's determination of whether to require an impact assessment for the Project. If an impact assessment is required, the Agency will prepare the draft Tailored Impact Statement Guidelines and the draft Indigenous Engagement and Partnership Plan.

To date, we have not received information or views about potential effects of the Project from Kitigan Zibi Anishinabeg. If the Agency does not receive information from your community by November 8, 2022, Kitigan Zibi Anishinabeg will not be included in the draft Indigenous Engagement and Partnership Plan, and will be notified of future impact assessment milestones.
