

1. Introduction

On March 22, 2024, the Impact Assessment Agency of Canada (the Agency) issued an opinion that an impact assessment is warranted for the Great Bear Gold Project (the Project), in alignment with the Government of Canada's Statement on the Interim Administration of the *Impact Assessment Act* Pending Legislative Amendments¹.

Aspects of the Project will likely be subject to the provincial Class Environmental Assessment (EA) for Resource Stewardship and Facility Development Projects pursuant to Ontario's *Environmental Assessment Act*, and to various provincial permitting and approval requirements that include an assessment of environmental effects.

This Plan was developed by the Agency with input from Ontario ministries to set out intentions and plans for a cooperative assessment process for the Project, following Kinross Gold Corporation's (the proponent's) decision to continue to advance the assessment process and proceed with the Planning Phase for the Project. The provincial ministries participating in the impact assessment are included in Appendix 1.

This Plan is intended to be flexible and does not preclude the Agency and participating ministries from modifying the cooperative approach described in this Plan in order to accommodate changes that may occur during the assessment process.

2. Project scope

The proponent is proposing the construction, operation, decommissioning and abandonment of a new open-pit and underground gold mine with an on-site metal mill, located 23 kilometres southeast of Red Lake, Ontario. As proposed, the Great Bear Gold Project would include three open-pits and produce up to 60,000 tonnes of ore per day, while the metal mill would process up to 15,000 tonnes of ore per day. The project would operate for about 20 years.

3. Approach to cooperation

Through cooperation, the Agency and participating ministries will strive to increase efficiency and certainty for all participants, including the proponent, the public, and Indigenous communities, by sharing information and expertise, coordinating activities, and harmonizing timelines where possible.

The following table outlines potential opportunities for cooperation, subject to proponent timelines for planning and design decisions, and sequencing of approvals.

The Agency has prepared draft Tailored Impact Statement Guidelines that set out the information required of the proponent in the Impact Statement.

The Agency and provincial ministries may participate in technical working groups with the proponent, Indigenous communities, federal expert departments, and community groups, as appropriate.

5. Timelines and time management

The proponent will work with MNRF to determine if any technical reports are required for the Resource Stewardship and Facility Development Class EA(s). If technical reports are required, the proponent may choose to coordinate them with the Impact Statement. If the technical reports are coordinated, the Agency and MNRF can coordinate the government review and comment period on the technical reports.

Where suitable, the proponent and participating ministries are also encouraged to align early government review and engagement for permits and approvals with the Agency's comment period on the Impact Statement or draft Impact Assessment Report and potential conditions.

This Plan recognizes that the alignment of respective timelines may be subject to obligations prescribed in applicable legislation, as well as the completeness of any information submitted by the proponent.

The Agency will provide the participating ministries listed in Appendix 1 with advanced notice of opportunities for cooperation. The Agency will also ensure that timely and effective communication occurs with participating ministries throughout the impact assessment process.

6. Sharing of information

The Agency and participating ministries will share, as appropriate, the following information obtained during the assessments of the Project on matters identified in Table 2:

- expert advice received;
- existing studies and information;
- comments from Indigenous communities, when not prevented due to confidentiality;
- information received from the proponent (e.g. technical submissions, responses to deficiency reports); and
- provincial regulatory, policy or other instruments and measures that could manage potential adverse effects of the Project (i.e. complementary measures), and regulatory decision criteria.

The Agency and participating ministries will, subject to applicable legislation, endeavour to respect preferences of Indigenous communities related to confidentiality of Indigenous Knowledge.

7. Public participation

If the province or proponent identify any comment periods for the Class EA or for permits and approval applications that can be aligned with comment periods for the federal impact assessment, the Agency will collaborate with participating ministries to include links to each others' websites, coordinate public notices, and share comments received, where appropriate.

8. Indigenous consultation and engagement

The Agency will lead Crown Consultation on behalf of the Government of Canada for this federal impact assessment, while the proponent and participating ministries will be responsible for Crown consultation for provincial decisions. 9. Decision Statement

The Agency will consult with participating ministries regarding proposed conditions for the Decision Statement and any relevant complementary measures to improve regulatory efficiency.

10. Interpretation

The Plan is not a legal document and does not change any existing federal or provincial legislative or regulatory jurisdiction, right, power, privilege, prerogative or immunity by virtue, nor does it create any new legal powers, duties or legally binding obligations.
