1. Introduction

On February 6, 2025, the Impact Assessment Agency of Canada (IAAC) and the Cree Nation Government signed an agreement¹ to ensure the involvement of the Crees in the impact assessment of the Shaakichiuwaanaan Mining Project (the Project). The agreement delegates all aspects of the impact assessment to a joint assessment committee (the Committee), composed of members of IAAC and the Cree Nation Government. Final decision-making, however, remains the responsibility of the Minister of the Environment and Climate Change.

On May 28, 2025, IAAC, in collaboration with the Cree Nation Government, determined that an impact assessment was required for the Shaakichiuwaanaan Mining Project, pursuant to section 16 of Canada's *Impact Assessment Act* (IAA).

The draft Public Participation Plan was developed to set out opportunities for public participation during the impact assessment process. It is also intended to be flexible and does not preclude the Committee from making changes to the approaches described in the plan in order to accommodate changes that may occur during the assessment.

2. Project Description

Patriot Battery Metals is proposing the construction, operation, decommissioning and closure of a new hybrid open-pit and underground lithium mine located about 250 kilometers east of Radisson, Quebec. As proposed, the Shaakichiuwaanaan Mining Project would include an ore processing plant, a water treatment plant a workers' camp, and storage areas for waste rock, tailings and ore. The mine would produce 49,500 tonnes of ore per day over a mine-life of about 24 years.

3. Objectives of Public Participation

The Public Participation Plan was developed as a result of consultations conducted during the planning phase and outlines the various ways in which a participant can provide input and be involved in the process, including those participants who will be most affected by the Project. The following public participation objectives reflect the views heard during the planning phase:

- The Committee informs the proponent about the concerns raised by the participants; and
- Public views heard throughout the process and related to federal jurisdiction are tracked and inform decision-making.
